## Attestation of Pakistan Driver's License

### Requirements:

#1 – 5 must be submitted to our office.

- 1) Filled in [Form](#) (do not give information other than on the driver's license)
- 2) Valid or Expired Pakistan Driver's License or International Driving License/Permit - Original and **photocopy of front and back of driver's license is required.**
- 3) Computerized National Identity Card (CNIC) or National Identity Card for Overseas Pakistanis (NICOP) or Pakistan Passport – Copy
- 4) Applicants sending their documents through mail should invariably enclose a self-addressed registered pre-paid return envelope with their application to the Consulate General of Pakistan in Vancouver.

#### **Debit/Credit card:**

In person: Payment can be made by debit/credit card in our office.

#### **Bank draft/money order/certified cheque:**

In person: Bank draft/money order/certified cheque already issued in favour of Consulate General of Pakistan will still be accepted.

By mail: Applications sent by mail must be paid by bank draft/money order/certified cheque already issued in favour of Consulate General of Pakistan.

**Processing Time:** Verification of driving license is done after receiving clearance from Pakistan which usually takes 6-8 weeks. Please note that we have no control over replies received from license issuing authorities in various districts of Pakistan. In some cases they take a long time to reply and we must wait for verification from their end. We regret any inconvenience caused in this regard.
