Search Instructions:

1. Press CTRL + F on your keyboard.
2. Enter subject title or page number in the search box.
Example: To enter the page number put “2 of 6”.
3. Press enter.

Disclaimer

Please note the following information:

1) You are not guaranteed a visa when you apply. You may submit a visa application and a decision will be made if a visa will be granted or not.

Entry time and duration of stay in the visa will be decided by the issuing authority if the visa is approved.

Additional documents may be requested after reviewing your visa application. If this is the case you would receive a call/email from our office.

2) Not all visa applications will be processed in the time frame mentioned.

3) You are advised not to book/purchase your flight before receiving your travel document. This is recommended in case your visa is denied/delayed or your shipment is delayed/lost from the courier.

Your visa application will be returned un-processed in the following cases:

1. No original passport provided.

2. The application is not signed.

3. Passport sent without duly filled in visa application form.

Returning the application would not mean the denial of visa. You could re-send your application after fulfilling all the requirements.

Pakistan Tourist/Family Visa

Requirement Instructions:

- Requirements numbered 1, 2, 5, 6 & 8 are mandatory and must be submitted for each person applying.
- Those who can fulfill #3 are not required to provide the documents listed in #4.
- #7 is required for who wish to have his/her documents mailed back after processing.
- One visa form must be filled per applicant. An applicant is defined as the person we are issuing the visa to.

Example: If you are applying for a visa for yourself and your child you must fill out two visa forms.

- All requirements must be submitted per application.

Example: If you are submitting two visa applications; one for yourself and one for your child we will need two sets of photographs from yourself and two sets of photographs from your child. You will have a total of four photographs in the end.

Requirements:

1. Completely filled in [visa form](#)

The visa form must be filled completely.

Address of where you are residing during your stay must be filled on the section of the form “xii Address & Email, b. In Pakistan” on page 2.

Example: If you are staying in a hotel the address and contact details of the hotel must be filled here.

If you are staying at a friend’s/family members place the address and contact details of the concerned person must be filled here.

2. Completely filled in [NOC form](#) (this form must be submitted along with visa application form for children below 18 years of age)

3. **Additional requirements for Pakistani citizens:**

Please establish that you are a Pakistani citizen by submitting a copy of valid or expired CNIC/NICOP or Pakistan passport.

Children of Pakistanis who are born outside of Pakistan are citizens by descent. Those who have not been issued CNIC/NICOP or Pakistan passport may provide copies of parent’s valid or expired CNIC/NICOP/Pakistan passport and a copy of your birth

certificate to establish the link to your parents.

If one parent is not a Pakistani citizen you may provide of a copy of his/her valid or expired passport of the concerned country.

4. Additional requirements for **non-Pakistani** citizens:

Friend/family visit: Those who are going to visit friends/family require an invitation letter.

Invitation letter must be signed and dated from host in Pakistan with a copy of valid government issued photo id from host. Invitation letter must contain visa applicant's full name and date of birth.

Our office will only accept the original invitation letter along with a photocopy of the host's valid government issued photo id from host.

Tourism: Those who are going for the purpose of tourism and staying in a hotel must provide a printed copy of the hotel reservation.

Trekking/Mountain Climbing: Any person going trekking/mountain climbing in Pakistan must have permission first before applying for a visa. Please visit this [page](#) for details on how to apply. After receiving the permission documents you may apply for the visa with a copy of the permission documents.

5. Valid passport

Original passport along with a photocopy of passport must be submitted.

Photocopy/s of passport must contain the page that has your information and copies of any previous Pakistan visa's that were issued.

Passport must be valid at least for 6 months from traveling date.

If holding other than Canadian Passport please provide one of the following proof of legal resident status in Canada:

- valid PR Card
- valid Work Permit
- valid Study Permit

Original proof of legal resident status in Canada is required along with a photocopy
or

Notarized copy of legal resident status in Canada may be submitted in lieu of the original. Copy must be notarized by a notary public or lawyer.

6. Two colour photographs are required.

Instructions

- Photograph must be duly stamped with the date by a photographer in Canada.
- Photograph must be taken within the past three months.
- The size of the photo to be submitted is 1.5” width by 2.0” height with a light blue or white background.

7. Pre-paid self-addressed registered mail return envelope.

One return envelope may be submitted for group applications. Please contact your courier for weight/size specifications.

In person: Those who submit application/s in person can have their documents returned by mail. If you are unable to come in person for pickup of your documents you may provide a return envelope to enable us to return your documents to you.

By mail: Those who cannot pickup their documents after processing must include a return envelope to enable us to return your documents to you.

Envelope Instructions:

- Accepted couriers for return shipping are Canada Post, UPS or Purolator.
- You may use any courier to ship your application to us (from your place to ours).

For return shipping (from our office to your place) we would only accept shipping labels/envelopes from Canada Post, UPS or Purolator.

- Canada Post: All types of Canada Post envelopes would be accepted such as Priority and Xpresspost envelopes as well as computerized shipping labels generated on www.canadapost.ca.
- Other Couriers: [Computerized shipping label/s](#) will only be accepted from UPS or Purolator. [Manual shipping labels](#) are not accepted. No other couriers except for UPS or Purolator would be accepted for shipping.
- Applicants are requested to retain a copy of the shipping label/s which includes important information such as tracking numbers for registered mail shipments. Courier tracking numbers will be required in case package confirmation is required.

8. **Fee table for Canadian and Afghan passport holders:**

*If holding a country of passport that is not mentioned please contact our office for the fee.

Payment

Debit/Credit card:

In person: Payment can be made by debit/credit card in our office.

Bank draft/money order/certified cheque:

One bank draft/money order/certified cheque may be submitted for multiple applications.

In person: Bank draft/certified cheque or money order already issued in favour of Consulate General of Pakistan will still be accepted.

By mail: Applications sent by mail must be paid by bank draft/certified cheque or money order issued in favour of Consulate General of Pakistan.

Fees

Single Entry Visit Visa | \$100 CAD

3 month travel time with one entry and a maximum of 90 days stay

Multiple Entry Visit Visa | \$150 CAD

Upto one-year Travel time

Multiple Entry Visit Visa | \$200 CAD

More than 1-year travel time with multiple entries within 1 year and a maximum of 6 months stay per visit.
