Disclaimer

Please note the following information:

1) You are not guaranteed a visa when you apply. You may submit a visa application and a decision will be made if a visa will be granted or not.

Entry time and duration of stay in the visa will be decided by the issuing authority if the visa is approved.

Additional documents may be requested after reviewing your visa application. If this is the case you would receive a call/email from our office.

2) Not all visa applications will be processed in the time frame mentioned.

3) You are advised not to book/purchase your flight before receiving your travel document. This is recommended in case your visa is denied/delayed or your shipment is delayed/lost from the courier.

Your visa application will be returned un-processed in the following cases:

- 1. No original passport provided.**
- 2. The application is not signed.**
- 3. Passport sent without duly filled in visa application form.**

Returning the application would not mean the denial of visa. You could re-send your application after fulfilling all the requirements.

Pakistan Visa on Indian Passport

Requirements:

#1 – 9 must be submitted to our office.

1. Filled in [Visa form](#) (Four Copies).
Two copies of the form will be returned to the applicant with visa. One each should be handed over to Pakistan Immigration Officer on arrival and Police Registration Office.
2. Filled in [Computer Proforma](#) (Four Copies).
Please clearly fill sponsor's complete address in Pakistan along with contact numbers and applicant's complete residential address in India.
3. Valid Indian Passport

4 photocopies of your Indian passport must be submitted.
Your passport must be valid at least for 1 year from traveling date. **Do not submit original passport until later date.**
4. **Provide one of the following proof of legal resident status in Canada:** valid PR Card, valid Work Permit or valid Study Permit

4 sets of notarized copies must be provided of your proof of legal resident status in Canada.

Notarization must be done by a notary public or lawyer.
5. Four identical most recent colour photographs are required.

Photographs must be duly stamped with the date by a photographer in Canada, taken within past three months.
The size of the photo to be submitted is 45mm high by 35mm wide with a light blue or white background.
6. **Additional requirements:**
Tourism or friend/family visit: Those who are going to visit for tourism or to see friends/family require a signed invitation letter from a sponsor.

The signed invitation letter by the sponsor in Pakistan must detail the purpose of visit. Your sponsor must include photocopy of his/her valid ID.

Invitation must be on stamp paper of any denomination; original must be notarized by a notary public or lawyer, and submitted in original.

Pilgrimage visit: Those who are going for pilgrimage purposes require a recommendation letter from local registered tour operator/local gurudwara in Canada and Pakistan.

Our office will only accept the original letter.

7. Details of boarding and lodging arrangements in Pakistan

Printed copies of boarding and lodging arrangements in Pakistan will be accepted.

Payment

Debit/Credit card:

In person: Payment can be made by debit/credit card in our office.

Bank draft/money order/certified cheque:

One bank draft/money order/certified cheque may be submitted for multiple applications.

In person: Bank draft/money order/certified cheque already issued in favour of Consulate General of Pakistan will still be accepted.

By mail: Applications sent by mail must be paid by bank draft/money order/certified cheque already issued in favour of Consulate General of Pakistan.

Fee: CAD 15.00

9. Applicants sending their documents through mail should invariably enclose a self-addressed registered pre-paid return envelope with their application. Applicants are requested to note down the incoming and outgoing tracking # with the courier service in case package confirmation is required.

Processing Time : Issued after the approval from Pakistan. Please allow minimum two months to process approval from concerned authorities in Pakistan.
