Before sending your application by mail, please make sure that the application form is complete and signed and all required documents are attached. For list of required documents please refer to the relevant section below.

Please note all those documents which require to be notarized must be signed by a Notary Public or a Lawyer and not by a Commissioner for Oaths. Only Affidavits could be signed by Oath Commissioners.

Transportation of dead body to Pakistan/ Issuance of certificate confirming death

\*A certificate from our office will be issued once your application is processed.

#### **Requirements:**

#1–6 and 8 must be submitted to our office.

1. Pakistan Passport of the deceased person

Instructions:

Original Pakistan passport must be submitted along with a photocopy. The original passport will be cancelled and returned.

2. Computerized National Identity Card (CNIC) or National Identity Card for Overseas Pakistanis (NICOP) of the deceased person

Instructions: Original CNIC/NICOP must be submitted along with a photocopy.

3. Death Certificate of the deceased person

#### Instructions:

Original death certificate must be submitted along with a photocopy.

4. Embalming Certificate issued by the funeral home (mandatory for transportation of dead body to Pakistan. If body is not being transported this may be omitted)

#### Instructions:

Original embalming certificate must be submitted along with a photocopy.

5. Certificate of non-communicable diseases (mandatory for transportation of dead body to Pakistan. If body is not being transported this may be omitted)

#### Instructions:

Original certificate of non-communicable diseases must be submitted along with a photocopy.

This is a certificate issued by the respective health authority of each province detailing if the deceased person has any diseases. Certificates issued by health authorities for shipment of body out of province may be accepted as long as it contains details specifying if the deceased person has any diseases.

6. A letter from the Funeral Home

<u>Instructions:</u> Original letter from the Funeral Home must be submitted along with a photocopy.

- 7. Fee: There is no fee required for this service.
- 8. Applicants sending their documents through mail should invariably enclose a selfaddressed registered pre-paid return envelope with their application to the Consulate General of Pakistan in Vancouver.

Applicants are requested to note down the incoming and outgoing tracking # with the courier service in case package confirmation is required.
